The Deposit A will be applied to the purchase price payable by the participant to Stockland at settlement of the relevant contract of sale; or  (b) for Qualifying Land that are townhome house and land packages that involve split contract arrangements with a selected Builder:  (i) a reduced deposit of:
	A. \$5,000.00 (including GST) for the purchase of land under the contract of sale ("Stockland Incentive"); and
	B. \$5,000.00 (including GST) for the construction of Qualifying House on Qualifying Land under the Building Contract, (together, " <b>Deposit B</b> "); and

- (ii) the participant must pay the Deposit B by the respective dates required under the contract of sale and Building Contract for the relevant residential lot within the Qualifying Land. The Deposit B will be applied:
  - A. as to \$5,000.00 (including GST) to the deposit payable by the participant to Stockland on exchange of the relevant contract of sale; and
  - B. as to \$5,000.00 (including GST) to the deposit payable by the participant to the Builder at the time of signing of the relevant Building Contract.

The Deposit A or Deposit B is not a rebate or a price reduction.

Each participant is responsible for informing their lender (if any) about the Deposit A or the Deposit B.
