1 Introduction

- 2.2 **Will we use your personal information primarily** to provide you with information on our products and services and for research, and we may combine that with other information we may have previously collected. - 3 Duration**
- 3.1 This Promotion runs from 9:00am Thursday 7th to 10.30am Friday 8th December 2017(“**Promotion Period**”). This is the period that the Centre will be receiving the cakes.
- 4 Eligibility**
- 4.1 This Promotion is only open to all residents of Australia.
- 4.2 Entrants under the age of 18 must obtain permission from their parent or legal guardian over the age of 18 to enter the Promotion.
- 4.3 Directors, officers, management, suppliers and their employees (and the Immediate Families of directors, officers, management, suppliers and employees) of the Promoter or of its related bodies corporate or agencies are ineligible to enter the Promotion. ‘Immediate families’ means any of the following: spouse (including same sex spouse), ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, natural or adopted sibling, whether or not they live in the same household as the director, officer, manager, employee or contractor.
- 4.4 If the entrant is under the age of 18 years, the Prize will be awarded to the winner’s nominated parent or guardian.
- 5 Competition Entry**
- 5.1 To enter, entrants must:
- (a) decorate a cake or polystyrene of any size with fondant covering to depict a Christmas theme;
 - (b) the size of cake board must not exceed 40cm x 40cm;
 - (c) if cupcakes are entered there must be a minimum of 6;
 - (d) not use buttercream, cream or ganache when decorating their cake;
 - (e) not use wires to penetrate the surface of the cake;
 - (f) not use natural plants or flowers, pins or glass of any description;
 - (g) not use porcelain or manufactured ornaments to decorate the cake;
 - (h) deliver their decorated cake to the Centre Management Office at Stockland Baldivis by 10:30am, Friday 8th December 2017; and
 - (i) obtain an entry form from the Centre Management Office, complete the form in full and hand the entry form to the staff at the Centre Management Office to enter their decorated cake to compete in one of the following categories:

- (i) Open Cake Decorating Business: For entrants over the age of 18 who own or work for a cake decorating business
- (ii) Open Hobby Decorator: For entrants over the age of 18 who decorate as a hobby and do not have an ABN;
- (iii) Amateur: For entrants over the age of 18 who decorate cakes as a hobby, do not have an ABN and have not previously won 1st prize in the Amateur section of a Stockland competition ;
- (iv) Primary Youth: For entrants 11 years or under
- (v) Secondary Youth: For entrants 12 – 17 years.

- 5.2 An entrant is permitted to submit more than one decorated cake into the Promotion.
- 5.3 The Promotor reserves the right not to display any cakes that deem to be offensive.
- 5.4 All valid entries received during the Promotion Period will be displayed in the area outside Kmart in Stockland Baldivis from 9.00am Saturday 9th December 2017 to 3.00pm Saturday 23rd December 2017.
- 5.5 Cakes can be collected after 3.00pm on Saturday 23rd December 2017. Any entry not collected by 4.00pm Sunday 24th December 2017 will be disposed of.
- 5.6 An entry cannot be modified after it is submitted.

6 How to Win

Industry Judge Award

- 6.1 At 11:00am, Friday 8th December 2017, the Promoter and its representatives (“Judges”) will select the best decorated cakes from each category out of the cakes which are on display in Stockland Baldivis. An accredited judge from the Western Australian Cake Decorators Association (Inc) will judge this category.
- 6.2 The winners in the Open, Amateur and Youth categories will win the following prizes:
- (a) Open Cake Decorating Business Category Winner: \$500 Stockland Gift Voucher;
 - (b) Open Cake Decorating Hobby Category Winner: \$500 Stockland Gift Voucher;
 - (c) Amateur Category Winner: \$300 Stockland Gift Voucher;
 - (d) Primary Youth Category Winner: \$100 Stockland Gift Voucher; and
 - (e) Secondary Youth Category Winner: \$100 Stockland Gift Voucher.
- 6.3 The runners up in the Open, Amateur and Youth categories will win the following prizes:
- (a) Open Cake Decorating Business Category Runner Up: \$400 Stockland Gift Voucher,

- 6.5 Members of the public may obtain a voting form from any Stockland Baldivis Retailer when making a purchase during the voting period of any amount, complete the voting form in full and place the completed voting form into the competition barrel next to the competition display in Stockland Baldivis.
- 6.6 The Centre Management Office will count the number of votes from the public for each cake in the five categories at Stockland Baldivis at 1:00pm, Monday 11th December 2017.
- 6.7 The entries with the highest number of votes from the public in the Open, Amateur and Youth categories will win the following prizes:
 - (a) Open Decorating Business Category Winner: \$250 Stockland Gift Voucher;
 - (b) Open Cake Decorating Hobby Category Winner: \$250 Stockland Gift Voucher
 - (c) Amateur Category Winner: \$200 Stockland Gift Voucher;
 - (d) Primary Youth Category: \$75 Stockland Gift Voucher; and
 - (e) Secondary Youth Category: \$75 Stockland Gift Voucher.
- 6.8 The entries with the second highest number of votes from the public in the Open, Amateur and Youth categories will win the following prizes:
