

## **TERMS AND CONDITIONS – GIFT WITH A PURCHASE**

<b>Item 4: Gift</b>	2x Event Cinema Glendale Movie Tickets valued at \$20. There are a total of 40 Gifts redeemable per day of the promotion period.

#### **1 Introduction**

- 1.1 Participation in this Promotion and information regarding redemption of any Gifts forms part of these terms and conditions.
- 1.2 By submitting an entry into this promotion, entrants warrant that they have read, understand and agree to be bound by these terms and conditions. If the entrant is under the age of 18 years, each entrant's consenting parent or guardian is responsible for ensuring their familiarity with these terms and conditions at the time of participation. Entry into this Promotion is deemed acceptance of these terms and conditions.
- 1.3 A copy of these terms and conditions can be obtained from the Centre Management Office, Customer Care Centre, or the Stockland Glendale website.

#### **2 Duration**

- 2.1 This Promotion runs from 9:00am AEST on Thursday 20 September 2018 to 4:00pm AEST on Sunday 30 September 2018, or when the Gifts have been exhausted.

#### **3 Eligibility**

- 3.1 This Promotion is only open to residents of Australia.
- 3.2 Directors, officers, management, suppliers and their employees (and the Immediate Families of directors, officers, management, suppliers and employees) of the Promoter or of its related bodies corporate or agencies are ineligible to enter the Promotion. 'Immediate families' means any of the following: spouse (including same sex spouse), ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, natural or adopted sibling, whether or not they live in the same household as the director, officer, manager, employee or contractor.
- 3.3 If the participant is under the age of 18 years, the Gifts will be awarded to the winner's nominated parent or guardian.

#### **4 Method of entry**

- 4.1 To enter, participants must:
  - (a) Make a purchase of \$100.00 or more across any Participating Retailer at Stockland Glendale;
  - (b) the entrant can combine up to three (3) valid receipts to make qualifying spend

- (c) the entrant will need to present their clear and legible receipt/s indicating the qualifying spend of \$100.00 or more at the Customer Care Desk located near Coles to have the receipt/s verified and stamped
- (d) the entrant will then need to fill out a Prize redemption form; and
- (e) submit the form back to Customer Care in order to redeem gift.

- 4.2 After presenting a receipt(s) in accordance with clause 4.1, participants will immediately receive one Gift. Participants are entitled to one Gift per person, per day of the promotional period, with a maximum of redemption of three Gifts during the promotional period.
- 4.3 Each receipt will be validated. All receipts must be clearly identified as being from a Participating Retailer, and must carry a date from within the promotion period.
- 4.4 The redemption of the Gift will take place at the Customer Care Desk at Stockland Glendale located near Coles. The Customer Care Desk is open 9am 'til 5.30 Monday, Tuesday, Wednesday and Friday; 9am to 9pm Thursday; 9am to 5.00pm Saturday; and 10am to 4pm Sunday. The Promoter reserves the right to request winners to provide proof of identity and/or proof of entry validity in order to claim a Gift.
- 4.5 The Promoter reserves the right to verify the validity of entries and participants if and when required (including a participant's identity and place of residence) and to disqualify any participant who tampers with the entry process or who submits an entry that is not in accordance with these Conditions of Entry. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 4.6 Participants must sign a declaration that they have collected the Gift.

## **5 Gifts**

- 5.1 The total amount of Gifts for this Promotion consists of the number of Gifts noted in Item 4. All Gift values are in Australian dollars and are correct at the time of printing. The Promoter takes no responsibility for variations in the Gift value.
- 5.2 The Promoter does not warrant the merchantability, suitability and/or fitness for purpose of any goods and/or services awarded as a Gift.
- 5.3 Gifts are not transferable.
- 5.4 If the Gift (or part of any Gift) is unavailable, the Promoter, in its discretion, reserves the right to substitute that Gift (or that part of the Gift) to the equal value.

## **6 Release and indemnity**

- 6.1 The Promoter and its associated agencies and companies will not be liable for any loss or damage whatsoever which is suffered (including but not limited to direct or consequential loss), or for personal

injury or death suffered or sustained in connection with this competition or as a result of taking or using any Gift, except for any liability which cannot be excluded by law.

- 7.1 The Promoter reserves the right to vary the terms of, or cancel, this Promotion at any time without liability to any participant or other person, subject to applicable laws.

## **8 Decisions final**
