We will also use this information for research to improve our products and services. If you do not provide us with that information, we may be unable to process your entry.

- 4.2 Directors, officers, management, suppliers and their employees (and the Immediate Families of directors, officers, management, suppliers and employees) of the Promoter or of its related bodies corporate or agencies are ineligible to enter the Promotion.
