

Submission Deadline Sunday 24th of September



Stockland recognises the Traditional Custodians and knowledge-holders of the land on which Gadigal is situated where we live, work and play and pay our respects to their Elders past and present.

We welcome our Indigenous community to participate in the Art EOI as solo artists or inclusive group submissions. We foster art centred on storytelling, visually communicating knowledge of the land, events and beliefs, furthering connection to place, continuing cultural practices, and educating and creating cultural respect between everyone on site.



In the beating heart of Sydney's CBD, this Mural will capture a dynamic tapestry of urban vibrancy that captures this place as it is and as it was. Where art becomes a powerful conduit for cultural connection and creative energy. It will capsulate the spirit of diversity, innovation, and the timeless allure of Piccadilly.

The Opportunity

Stockland Piccadilly is seeking Expression of Interest (EOI)) from professional mural artists who are Australian residents and 18yrs or over.

This is a rare opportunity for a very visible and hightraffic site in the centre of the CBD – one block from Town Hall. This wall is adjacent to the entry to Piccadilly Centre - which houses Stockland Head Office and other businesses.

The Mural will be in the form of traditional paint. Artists are invited to showcase their creative and innovative designs, new ideas and sustainable practice.

All execution must conform to risk and safety in design standards, and the permanent artwork must be robust, durable and low maintenance (5-7yr installation).

Artist to submit a fee including all costs: mural installation, creative work and concept development, equipment such as lift platforms, travel, meals, media promo and insurance.

Stockland has allowed for consultant fees for photography and marketing.



- Artist's statement, an example of previous works.
- Project budget, installation programme and a copy of Public liability insurance (\$20m).
- Be available to complete as per timelines.

The Stockland arts panel will review all submissions and shortlist up to three artists. Shortlisted Artists will be provided with a \$500 fee to illustrate a concept due on the Sunday 22nd of October, 2023.

The final concepts will be published on social media channels to encourage community engagement and feedback. Stockland arts panel will select the final artwork and announce artists by Friday 17th of November, 2023.

The artwork installation period between Feb-June 2024. Subject to Development Application and approval safe weather conditions and agree with the Placemaking Manager. Most works can be installed during centre hours, subject to traffic management arrangements.











Mural Details

The mural canvas is located 133 Castlereagh Street:

- Existing Stone tile finish wall, along with timber fire doors will be prepared with a *Zinser undercoated in white, ready for Artist to apply paint.
- Size wall one ~5,830, wall two 2,850, x 3550mmH Check on site prior to install.
- Commercial paint must be able to withstand the outdoor climatic elements, be waterproof, non-toxic, UV stable
- Statutory signage to the fire doors will remain in current position. Poster including frame will be removed.
- Mural to extend over both walls, opportunity to provide ceiling spill, with artists wall elements flowing across to create a dynamic zone.
- The mural can be completed by one artist as a single submission or group of artists as one unified design
- Artist must include in the costing all equipment including hirer equipment such as boom lift or scaffolding if required. A safe-work-method report will be required prior to construction.
