PART A - INTRODUCTION

1. Information on how to enter and Prize details form part of these terms and conditions.
2. By participating in the Competition, entrants accept and agree to be bound by these terms and conditions. For the avoidance of doubt, the terms and conditions include the Schedule above.
3. Entries must comply with these terms and conditions to be valid.
4. Where there is an inconsistency between the Schedule and Parts A to J of these terms and conditions, the schedule will prevail.

PART B - PRIVACY

5. The Promoter will collect and use each entrant’s personal information for the purposes of:
 - (a) conducting the Competition (which may include disclosure to third parties for the purpose of processing and conducting the Competition) and for promotional purposes, public statements and advertisements in relation to the Competition;
 - (b) providing information about the products and services offered by the Promoter and its related companies and its affiliated retailers; and
 - (c) research to improve its products and services.
6. By entering the Competition, entrants consent to the use of their personal information as described in clause 5.

PART C - WHO CAN ENTER THE COMPETITION

8. If the Schedule permits entrants to be under the age of 18 years, such entrants must seek permission from their parent or guardian to enter. If the winner of a Prize is under 18 years of age, the Prize will be awarded to the winner's parent or legal guardian.
9. Directors and employees (and their immediate families) of the Promoter or its related companies or agencies and Participating Retailers are not eligible to enter. Immediate families means spouse, ex-spouse, child, step-child, parent, step-parent, legal guardian, sibling or step-sibling.
10. Entrants of the Willowdale Decorate Your House People's Choice Award are also permitted to enter this Competition.

PART D – HOW TO ENTER THE COMPETITION

11. To enter, each entrant must comply with the 'How to Enter' section of the Schedule.
12. If the Schedule permits entrants to submit more than one entry, each entry must be unique and submitted separately.
13. Entries must not have been published previously or used to win prizes in other competitions.
14. An entry cannot be modified after it has been submitted.
15. The Promoter reserves the right, at any time, to request verification of the age, identity, residential address or any other information relevant to participation in the Competition of all entrants. The Promoter reserves the right to disqualify any entrant who provides false information or fails to provide information that is reasonably requested by the Promoter.
16. The Promoter reserves the right, in its sole discretion, to refuse to accept entries which are incomplete, indecipherable, offensive, do not comply with these terms and conditions or which contravene any applicable laws or regulations.
17. The Promoter reserves the right, in its sole discretion, to disqualify any entrant who has breached any of these terms and conditions, has engaged in unlawful or improper conduct or otherwise acts to cheat or undermine the fairness of the Competition by, for example, tampering with, or using or exploiting errors in, the entry process to obtain a competitive advantage over other entrants.
18. The eligibility of entries is solely within the discretion of the Promoter.
19. The Promoter accepts no responsibility for late, lost, misdirected or damaged entries or other communications.
20. If entry is online, by telephone or SMS, the Promoter assumes no responsibility for any failure to receive an entry or for inaccurate information or for any loss, damage or injury as a result of technical or telecommunications problems, including security breaches. If such problems arise, then the Promoter may modify, cancel, terminate or suspend the Competition.

 - (c) that if they upload or otherwise cause another person's profile picture or other Facebook content to be made publically available (despite Stockland discouraging this conduct), that they have obtained consent from each person they add to submit that person's profile picture or other Facebook content;
 - (d) to release the Promoter from liability for their entry to the full extent permitted by law;
 - (e) to indemnify the Promoter against any claim, legal or otherwise that may arise out of the use or publication of the entry;

23. If entry is via Instagram, entrants acknowledge and agree that use of Instagram is subject to Instagram's terms and conditions. The Promoter is not responsible or liable for any loss, damage or injury suffered by any entrant as a result of the conduct of Instagram, including any decision by Instagram to remove or not remove any content, except for liability which cannot be excluded by law. 24. Each entrant acknowledges and agrees that it is responsible for the safe installation and maintenance of all decorations, lights and equipment used to participate in the Competition.
25. Each entrant acknowledges and agrees that it is responsible for all costs and charges (including electricity charges) incurred as a result of decorating their dwelling and displaying the lighting and/or decorations on or at their dwelling.
26. Entrants must not encourage members of the public to access any part of their property (including their dwelling) as part of the Competition. Any consent by an entrant allowing a member of the public to access any part of an entrant's property (including an entrant's dwelling) is given at an entrant's own risk.

PART E - PRIZES

27. Each Prize is not transferrable, exchangeable or redeemable for cash.
28. If a Prize is unavailable for reasons beyond the Promoter's control, the Promoter reserves the right to substitute the Prize with a prize of equal or greater monetary value. This right is subject to any applicable legislation, regulations or directions from a regulatory authority.
29. Once a Prize has left the Promoter's premises, the Promoter takes no responsibility for the Prize being damaged, lost or stolen.
30. All taxes (excluding GST, if any) which may be payable as a consequence of receiving a Prize are the sole responsibility of each winner.
31. A winner's use of the Prize is entirely at their own risk. 33. At the time and date specified in the "Determining the winner(s)" section of the Schedule, each valid entry will be judged individually on its merits by the Judges based on the Content Criteria.
34. The winner of the First Prize will be the entry that best satisfies the Content Criteria, as determined by the Judges.
35. The winner of the Second Prize will be the entry (excluding the entry submitted by the entrant that wins the First Prize) that best satisfies the Content Criteria, as determined by the Judges.
36. The winner of the Third Prize will be the entry (excluding the entry submitted by the entrant that wins the First Prize and the entry submitted by the entrant that wins the Second Prize) that best satisfies the Content Criteria, as determined by the Judges.
37. The number of winning entries to be selected will be the same as the total number of Prizes specified in the Schedule
38. The Judges' decision will be final and binding and no correspondence with entrants or any other person will be entered into.
39. Each winner will receive a Prize.

PART G - NOTIFICATION AND CLAIMING THE PRIZE(S)

40. The Promoter will provide each winner with instructions on how to claim their Prize. It is the responsibility of each winner to comply with the Promoter's instructions.
41. The Promoter reserves the right to request each winner to provide proof of their identity and/or proof that they were responsible for the winning entry.
42. Each winner agrees to participate and cooperate, as required, in all publicity activities relating to the Competition, including, without limitation, being interviewed, photographed, filmed and recorded. Each winner authorises the Promoter to use such content for advertising and publicity purposes in any media in perpetuity worldwide.

PART H - UNCLAIMED PRIZES

44. The Promoter will take all reasonable steps to identify and notify each winner in an attempt to ensure that each winner receives their Prize. However, if a winner cannot be identified or does not claim the Prize within three months of the date on which the winners are determined, their Prize is forfeited and will be awarded to the next best entry.
45. Each winner of an unclaimed Prize will be determined and notified in accordance with Parts F and G.

PART I – NO LIABILITY

46. Any Prize supplied by a third party supplier is subject to the terms and conditions of that third party supplier. Each Prize may come with guarantees that cannot be excluded under the Australian Consumer Law. If those guarantees are not complied with, then you will have rights under the Australian Consumer Law. Subject to those guarantees and rights, the Promoter shall not be liable and excludes all liability (including negligence) for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) for damage to property, personal injury or death suffered or sustained in connection with the Competition or the use or taking of any Prize except for any liability which cannot be excluded by law including as provided for under the Australian Consumer Law.
