

## PROCESS FOR PARTICIPATING IN AURA LAND RELEASES

All land releases at Aura will be moving to an online ticketing system via Eventbrite.

The process will mean that if you are successful in registering your interest, you will receive a ticket from Eventbrite via email (sender will be [noreply@orders.eventbrite.com.au](mailto:noreply@orders.eventbrite.com.au)). Online registrations are time stamped and tickets will be allocated based on the time of registration. Allocation of home sites will be at the sole discretion of Stockland.

At the end of the registration period our sales team will call recipients to schedule an appointment.

Please note not all participants that receive a ticket will be successful in securing an opportunity to purchase land in the Land Release and investment opportunities are limited.

Please read the below steps to participate in land releases at Aura.

### BEFORE THE RELEASE:

1. Learn about the new process [here](#);
2. Create your own Eventbrite Account by clicking [here](#);
3. Keep an eye on your inbox - an email with release information and important dates will be sent to you approximately one week before the release day and an email reminder with the link to the Eventbrite release page one (1) day prior;
4. Review the sales plan and price list contained in the release information email from Stockland and have a shortlist of your top three (3) land preferences ready. The submission process through Eventbrite will ask you for three (3) land preferences;
5. Contact our sales team to discuss any questions or queries that you have in regards to this release process;
6. Ensure you have the correct paperwork to be eligible for an appointment; In order to be eligible for an appointment, you must provide your Finance Pre-Approval from your lender, or a Letter of Eligibility from your broker. If you do not require finance, please confirm this via email to [aura@stockland.com.au](mailto:aura@stockland.com.au) once you have successfully received a ticket;
7. You should use this time to consult your builder/broker and Stockland Sales Professional about suitable options for you.

### ON THE DAY OF RELEASE:

1. Registrations for this Land Release will open on the Eventbrite page on Saturday 7th August 2021;
2. You will need to use the link from the email issued prior to the release day. Refresh the Eventbrite page if you access the page prior to 8:00am (Park Avenue Release) or 9:00am (Lindmean Release);
3. Click the green 'Register' button and complete your information in order to register your interest;
4. Tickets will be allocated based on time of registration until allocation has been exhausted;
5. If you secure a ticket, a member of our sales team will call you from 12noon - 2pm (Park Avenue Release) and 2pm - 5pm (Lindeman Release) on Saturday 7th August 2021 (release date) to confirm the outcome of your ticket. Stockland reserves the right to determine the order by which ticketholders will be contacted in its absolute discretion;
6. You will be contacted twice during this time and if you are uncontactable both times, you will lose your ticket and the opportunity to purchase in this release, if all lots are allocated.

## POST RELEASE

1. Contracts are to be signed with payment of the deposit (\$10,000) within seven (7) days of the release date;
2. If you are unsuccessful in securing a ticket or securing a lot, please stand by for our next land release.

Please note that only one online registration can be submitted per buyer/buyers for each release. Multiple online registrations submitted under different names will result in disqualification of your eligibility to participate in the release.
